# 7. AUTOMATIC TRANSFER SWITCH FOR MAIN OFFICES

General Manager Joe Guzzetta reported. The automatic transfer switch will improve operations in the office during power interruptions and may make a significant difference in the District's ability to respond to emergencies. This item was included in the budget. Board and staff discussion ensued and the following action was taken:

MSC Reynolds/Long 4/0 (1 Absent) to approve staff recommendation to authorize purchase of an automatic transfer switch at the main Joshua Basin Water District offices at a cost of \$6,627 from David Price, and appropriate \$7,300 for the project.

# 8. BOARD OF DIRECTORS TO CONSIDER ANNUAL APPROVAL OF THE INVESTMENT POLICY

Assistant General Manager/Controller Susan Greer reported that Government Code requires that the District re-approve the investment policy annually. There are no proposed changes to the policy. Nearly all investments are with the Local Agency Investment Fund (LAIF). Discussion ensued. Director Whitman suggested that alternatives to LAIF be discussed at a future Board meeting.

- Al Marquez of Joshua Tree commented that he is not familiar with the District's investment policy; he was provided with a copy.
- MSC Long/Whitman 4/0 to approve staff recommendation to approve the investment policy.
- President Luckman appointed Vice President Reynolds and Director Whitman as an Ad Hoc Investment Committee.
- 9. RESOLUTION #10-862 HONORING LOCAL AGENCY FORMATION COMMISSION (LAFCO) EXECUTIVE DIRECTOR KATHLEEN ROLLINGS-MCDONALD ON HER RETIREMENT
- GM Guzzetta reported that Executive Director Kathleen Rollings-McDonald is retiring after 31 years with LAFCO. Board discussion ensued; President Luckman read the proposed resolution.
- MSC Reynolds/Whitman 4/0 to approve staff recommendation to adopt Resolution 10-862 honoring Local Agency Formation Commission Executive Director Kathleen Rollings-McDonald on her retirement.
